- (b) Zones 5, 8, 9, 10, 11 and 12 bussed to PCS, BUR or North Ward School (NWS)
- (c) Adjust PCS boundary south and move students from Cobblestone Elementary School (COB)
- (d) Designate growth areas as holding zones to other sites
