### C-1 Statements

Legacy requests for grade 7 and 8 students will be an option.

Younger siblings have the option to apply for Out of Attendance Area status but will not be guaranteed acceptance and to ride the bus these students would be courtesy students.

A possibility due to a lot of data, information and variables involved in this decision, we can land on a set of recommendations for September 2023 and defer some knowing we may need to meet again later this spring or fall with recommendations for 2024 or gather more data if required due to a tight timeline.

Holding zones are implemented for new developments to hold students at a school which is not in the area the home is purchased. In the future they may be moved to their home school, or the holding zone school could become the permanent school for that area.

Recommendations will be implemented for September 2023 if they are passed by the Board of Trustees on February 27, 2023.

### D - 1 Next Steps

The committee will add the following to their report for recommendation to the Board of Trustees to ensure inclusion on the next capital submission:

- 1. An addition to Cobblestone Elementary School (COB)
- 2. Seek to build a new elementary school in the Paris area.

The committee will recommend the following to the Board of Trustees:

- French Immersion grade 6 to 8 at Paris Central School (PCS) move to Burford District Elementary School (BUR).
- Areas 11 and 12 (see presentation) attend Glen Morris Central Public School (GLE).
- All students south of Blue Lake Road, to students residing on the north/west side of Clark Road to German School Road, from Clark Road to Kitchen School Road on the west side, and north side of German School Road East (#5) will move from St. George-German School (SGG) to (GLE).
- Area 5, 8 and 10 (see presentation) move from COB to North Ward School (NWS).
- Area 6.2 (see presentation) move from COB to PCS
- Area 9 (see presentation) move from COB to BUR.
- North of Dundas Street West will remain at COB.
- Area 1 (4 students affected) and north end of Area 2 (Golf North development) (see presentation) from PCS moved to NWS.
- Identify HZ2, HZ3 and HZ4 as holding zones with no receiving schools identified.
