North Brant Elementary Accommodation Review January 14, 2016 ARC Summary Notes from Meetings 1 & 2

1.0 Statement of Purpose and Responsibility

- An Accommodation Review Committee (ARC) was created in September 2015 in response to the Quality Accommodations Committee report approved by the Board of Trustees in April 2015.
- An ARC is created to provide advice to the Board on pupil accommodation matters for a school or group of schools
- The North Brant Elementary Accommodation Review was initiated to address the
 accommodation pressures related to French Immersion. As part of the review process,
 the capacity for Paris Central was clarified, and the rated capacity was increased from
 219 to 259. Based on the updated figures, Paris Central is operating below 75%
 capacity.

Information Sharing and Community Feedback

Meeting #1

There was a review of the ARC process, sharing of the accommodation recommendation from Senior Administration, and sharing of the Board's data with respect to the schools involved in the ARC. For Cobblestone Elementary, North Ward Public School and Paris Central School, an aerial map, a boundary map, enrolment projections, floor plans, site plans, a zoning map, and the School Information Profile were presented. This information is available on the GEDSB website. (At this point, Burford DES was not included in the ARC.)

- Board data is inaccurate.
- "Decision has already been made."
- Moving students is detrimental to their health.
- Move the boundary lines to adjust schools to the 75% capacity.
- Transportation issues need more attention.
- Burford parents have had no input into potential FI changes at Paris Central.
- Split FI between all Paris Schools to save the closure of Paris Central.
