# From the Principal

#### Dear Parents:

Well, we survived January! It was a cold one and the students had to be kept in for too many days to protect them from frostbite. Fortunately, the weather has now modified, so they can get out.

One issue that became very apparent during the cold snap was that a number of parents continued to pull their vehicles into the drive-through during peak times. This created some very dangerous moments. The drive-through is designated specifically and only for busses and the vehicles of a few of our Special Needs students. As well, emergency vehicles can use this area. For all other vehicles, this area is OFF LIMITS for the times 8:40 to 9:30 and 2:15 to 3:30. Our primary purpose for this restriction is to protect the safety of your children. We have seen a few close calls and a few instances where the busses were blocked by cars at a time when they needed to get in. They use the entire end of the drive-through depending on which students they are picking up. Students do walk onto the road, so the fewer cars in there, the better. We will be trying to assist parents in this matter by occasionally going outside to direct traffic. We do hope you understand.

Another safety procedure will be acted on this month. On Thursday, 28 February, at some time during the day, we will be having a Lock Down practise drill. We do let you know the day so that if you get a panicked text from a child, you will know it is just a drill. Again this is a legal requirement and is designed to protect your children.

Report cards go out on 14 February, Valentine's Day. We appreciate your support in the education of your children and ask that you contact your child's teacher if you have any questions about the report. Of course, I expect that you have already been apprised of your child's progress through the term, but we are always available for further discussion.



#### **Kindergarten Registration**

With the new year we begin our Kindergarten Registration. Children who will be four by the end of December 2019 are eligible for Junior Kindergarten and children who will be five by the end of December are eligible for Senior Kindergarten beginning in September.

#### IMPORTANT INFORMATION FROM THE OFFICE!

## **Smoke-Free Ontario Act: Changes Impact All Grand Erie Schools**

Last fall, the Government of Ontario passed the Smoke-Free Ontario Act, which prohibits smoking tobacco or cannabis as well as all vaping in public areas, including schools.

The new law specifically states that a person can not smoke or vape in or around a school. This includes all indoor spaces and all outdoor areas like playgrounds and sports fields. It also prohibits smoking and vaping in public areas within 20 metres of the property line of a school or School Board facility. For reference, 20 metres equals 65 feet, or the approximate length of 1.5 school buses.

A person caught smoking or vaping in a prohibited area may be charged with an offence and subject to a fine of up to \$1,000 for a first offence, if convicted.

To assist Grand Erie with this change, the local Health Unit will be providing new signage for all schools and Board facility sites. Through our Public Health Nurses, education information will be available for those looking to quit smoking or vaping. The Board will also be removing all traditional smoking and vaping areas.

Understandably, this is a significant change that will require everyone's cooperation. We don't want to see anyone charged. Therefore, we're asking for your support and assistance in ensuring everyone meets the requirements of this new law.
